Besides traveling equipment for mobile operations, they operate a communal space available for artists across the state and greater region, along with community-building events and lectures, exhibitions, and studio services in hybrid, in-person and virtual formats in a facility renovated with top-of-line air purification and disinfection equipment that follows COVID safety protocols.
